CDRL -3-001 -	Safety Plan	Within 90 Days of NTP. Annually thereafter or when changes to the process occur.
CDRL – 4-001	Employee Safety Reporting Program	Within 90 Days of NTP. Annually thereafter or when changes to the process occur.
CDRL – 5 -001	Safety Risk Management Program Risk Registry/Risk Assessments/CAPS	Include the log information for the current week with the Weekly Operations Report, and separately the entire current log Quarterly or upon request from Ride Gwinnett.
CDRL – 5-002	Safety Committee Process	Within 90 Days of NTP. Annually thereafter or when changes to the process occur.
CDRL - 5-003	Threat and Vulnerability Assessment	No later than 12 months from NTP and every three (3) years thereafter.
CDRL – 6-001	Employee Assault Reduction Program	Within 90 Days of NTP. Annually thereafter or when changes to the process occur.
CDRL-7-001	Internal Safety Review Program	Within 90 Days of NTP. Annually thereafter or when changes to the process occur.
CDRL-7-002	Internal Safety Review Program Annual Report	Annually within 30 days of the completion of the Annual Internal Safety Review Program.
