

**Notifying the public of and requesting comment on the Atlanta Urbanized Area (UZA) FTA Formula Funds  
Proposed Program of Projects**



In compliance with requirements and guidelines outlined in Federal Transit Administration (FTA) Circular 4702.1B, and the Atlanta-region Transit Link Authority (ATL) Title VI Program, comment is requested on the Atlanta Urbanized Area (UZA) FTA Formula Funds Program of Projects (POP). The formal public comment period begins April 23, 2021 and concludes May 24, 2021.

The POP outlines FTA formula program funds allocated to the Atlanta region, and shows projects selected for funding by local governments and eligible recipients. These FTA formula funds include the Section 5307 Urbanized Area Formula Program, 5337 State of Good Repair Grants Program, and 5339 Bus and Bus Facilities Program. The POP compliments the Atlanta Region Metropolitan Planning Organization’s (MPO) Transportation Improvement Program (TIP) which lists how all federal transportation funds are programmed. The TIP lists FTA formula suballocation funding amounts, while the POP provides detail at the project level. ATL, as Designated Recipient for the Atlanta region’s urbanized FTA formula fund apportionments is responsible for developing the Program of Projects from information provided by transit operators and local governments.
