CALL TO ORDER

Mr. Ehrhart, Committee Chair, called the meeting to order at 9:17 a.m. A quorum was confirmed.

APPROVAL OF THE SEPTEMBER 1, 2022 MEETING MINUTES

Federal interest now needs to be transferred to ATL with ATL serving as the primary grant recipient for Xpress service.

Mr. Ehrhart called for a motion to recommend the proposed Resolution Authorizing the Transfer of the Remaining Federal Interest in Assets Used for Operations of Xpress Services. Ms. Nash made the motion, and Mr. Mosby seconded. The Committee unanimously recommended the Resolution for Board consideration.

SUBRECIPIENT SHARED SERVICES PROGRAM - THREE RIVERS REGIONAL COMMISSION

Jonathan Ravenelle discussed the Subrecipient Shared Services Program with Three Rivers Regional Commission. The ATL will provide Three Rivers Regional Commission (TRRC) access to 5307 funding as part of its role as Designated Recipient for the 23-county Urbanized Area. The ATL and TRRC will enter a subrecipient relationship for a 2-year period. Funding will support TRRC operations for FY23 and FY24. TRCC will reimburse the ATL for staff time and support services.

Mr. Ehrhart called for a motion to recommend the proposed Resolution Authorizing the Submission of Project Applications for Federal Funding Support. Ms. Franklin made the motion, and Ms. Nash seconded. The Committee unanimously recommended the Resolution for Board consideration.

Mr. Ehrhart called for a motion to recommend the proposed Resolution Approving Subgrant Agreement with Three Rivers Regional Commission for Federal Transit Administration Funding. Ms. Franklin made the motion, and Ms. Nash seconded. The Committee unanimously recommended the Resolution for Board consideration.
