



Notifying the public of and requesting comment on the Disadvantaged Business Enterprise (DBE) Program for the ATL

In compliance with requirements and guidelines outlined in 49 CFR 26, the Atlanta-region Transit Link Authority (ATL) will update its DBE Program. ATL hereby announces its Federal fiscal years 2024 through 2026 goal of 10.31% for DBE participation in Federal Transit Administration assisted contracts. The proposed goal and rationale is available for inspection between 8:00 a.m. and 5:00 p.m., Monday through Friday at 245 Peachtree Center Avenue NE, Suite 2200, Atlanta, GA 30303.

A formal public comment period will begin on September 1 and conclude on September 30, 2023. There will be an opportunity to present comments verbally at a public hearing to be held Wednesday, September 20, 2023, from 12:00PM until 2:00PM and 5:00PM to 7:00PM, in the ATL Board Room on the 23rd floor of the Marquis One Tower at:
