### **Gwinnett Place Transit Center**

**Purpose:** Expand existing facility to increase transit services and function as the main hub for transfers within Gwinnett and for regional partners. Site will feature a mobility center with onsite customer service staff.

Project Phase: Implementation

Federal Grant: \$20M

GO Bond Request: \$5M

# **Overview of Georgia Transit Trust Fund**

#### Revenue generated from fee on all for-hire and shared-ride services

- \$0.54 on all ride hailing, taxi and limo trips
- \$0.27 per user on all shared for-hire trips
- Funding appropriated each year to Georgia Transit Trust Fund
- Funding of \$12,597,313 allocated by Trustee (GDOT Commissioner) to Atlanta region through ATL







### **Trustee Stipulations on FY24 Transit Trust Funds**

### Funding should be used to support one or more of the following

- 1) Economic development for growing businesses, jobs access, and tourism
- 2) Cross-jurisdictional job access
- 3) Projects that align with the Governor's initiative for Georgia as the *E-Mobility Capital of the U.S.*
- Funding should be utilized in the current fiscal year or no more than 3 fiscal years



# **MARTA Airport Station Rehab**

- Total Project Cost
  - \$55,000,000
- Transit Trust Fund Allocation
  - \$5,500,000 (10%)
- Project Purpose
  - Provides investment into MARTA Airport station as a major economic and tourism hub for metro Atlanta and the State of Georgia
  - Supports the installation of a new modernized translucent canopy element of the station with improved lighting to solidify its appearance with Hartsfield-Jackson Atlanta International Airport's terminal facilities and support an improved overall customer experience









### Buford/Sugar Hill/Suwanee Microtransit Project


#### Total Project Cost

- \$3,200,000
- Transit Trust Fund Allocation
  - \$960,000 (30%)
- Investment Period
  - 24-month service

#### Project Purpose

- Provides capital cost of contracting funding for new microtransit service
- Covers northwest portion of the county from Suwanee to Sugar Hill to Buford with Buford Highway retail and employment destinations as the spine







# **Cobb Microtransit Service Project**

#### Total Project Cost

- \$3,200,000
- Transit Trust Fund Allocation
  - \$960,000 (30%)
- Investment Period
  - 24-month service

# COBB LINC.

#### Project Purpose

- Provides capital cost of contracting funding for new microtransit service
- Offers curb-to-curb service within South Cobb and an ability to connect to the rest of Cobb and Atlanta region through other transit services





# **ATL Airport CIDs Microtransit Pilot**

#### Total Project Cost

- \$2,600,000
- Transit Trust Fund Allocation
  - \$780,000 (30%)
- Investment Period
  - 24-month service pilot

#### Project Purpose

- Provides capital cost of contracting funding for new microtransit service
- Offers flexible, on-demand public transportation option for Hartsfield Jackson Atlanta International Airport, a significant jobs center






# **Regional Planning Software Licenses**

#### Total Project Cost

- \$1,046,290
- Transit Trust Fund Allocation
  - \$209,258 (20%)
- Investment Period
  - 3-year contract for region
- Provides capital match for federal funding to maintain software licenses for regional transit operators
- Regional agencies have used software to support the following projects
  - Clifton Corridor Transit Initiative
  - Candler Road Arterial Rapid Transit Project
  - Cobb County Transit Development Plan
  - Gwinnett County Transit Development Plan
