CobbLinc launched on October 1st


Outreach efforts to riders are underway and will continue until early 2024

I-285 Express Lanes Transit Project


Project has officially kicked off

Sugarloaf Park and Ride Project

Increase to Park & Ride capacity near the Sugarloaf Mills identified in 2015 Comprehensive Operations Analysis for FY 2016-2026 implementation

Construction of facility started 02/18/2022 and expects to end 03/31/2024

► Total costs: \$13.9M

Intended to support routes 410, 412, 414, 417

• Subject to reevaluation by Redefine the Ride effort



Transit Trust Fund Agreements

TTF Agreements have been drafted

Agreements will be sent to project sponsors by the end of the year

Agreements expected to be fully executed by the end of Q1 2024
