At the next Board meeting, staff will propose a second amendment that will include the current universe of transit projects in the region,.

### COBB COUNTY TRANSIT PLAN

Laura Beall of Cobb County gave an overview of Cobb County's Transit Master Plan. In November 2022, the Board of Commissioners authorized Cobb County staff to develop a project list for an MSPLOST Referendum in November 2024. MSPLOST Referendum goals are:

- Connectivity to Regional Activity Centers
- Mobility within Activity Centers
- Serving the Community
