OVERVIEW of Grant 5337, State of Good Repair

The State of Good Repair (SGR) program provides federal formula funding to public transit agencies for maintenance, replacement and rehabilitation of capital assets

Eligible uses include capital projects and improvements:

- Mechanical Breakdowns
- Preventive Maintenance
- Technology Maintenance

► SGR covers 80% of the costs of eligible projects



ATL FY25 Grant Application- SGR- 5337

ATL has earned formula funds of \$2,131,508 which will lapse if not obligated in an FTA grant by September 2025

► ATL Spend Plan:

- \$1,031,508 for preventive maintenance among park and ride lots and vehicles, such as vehicle maintenance, HVACs, facility repairs, and backflow testing
- \$1,100,000 for the bus wash facility at South Ops
 - Including \$800k for replacing the bus wash and \$300k for the building extension
 - The existing bus wash does not operate, and the drainage structure does not comply with current EPA regulations

ATL FY25 FTA Grant Application	Amount	Purpose
GA-2025-TBD	\$2,131,508	New application with funding for Xpress preventive maintenance and a new bus wash facility at South Ops
