CALL TO ORDER

Committee Chair Steve Brock called the meeting to order at 10:06 a.m. A quorum was confirmed for the meeting.

APPROVAL OF THE MINUTES OF THE PREVIOUS MEETING

Committee Chair Steve Brock called for a motion to approve the minutes from the February 6, 2025, meeting. Mr. Teddy Russell made the motion to approve, and Mr. Howard Mosby seconded the motion. The minutes were unanimously approved.

APPROVAL OF THE COMMITTEE AGENDA

Committee Chair Steve Brock called for a motion to approve the agenda. Mr. Robb Pitts made the motion to approve, and Ms. Lorraine Cochran-Johnson seconded the motion. The agenda was unanimously approved.

PROPOSAL FOR AWARD OF REMAINING FY24 TRANSIT TRUST FUND

Abby Marinelli presented a proposal for the allocation of the remaining FY24 Transit Trust Fund (TTF) dollars. The Atlanta region initially received just over \$12.5 million in transit trust funds, of which slightly more than \$10 million has already been allocated, leaving an unobligated balance of \$2.21 million. Staff recommended awarding this remaining amount to two projects:

- 1. Automated Vehicle Pilot on the Beltline
- 2. Phase One of the IPECs (In-Person Employment Centers) Study

FY25 TRANSIT TRUST FUND COMPETITIVE PROCESS

Abby Marinelli introduced the implementation of a formal competitive process for allocating an initial \$15M of total available \$20M in FY25 TTF funding. For FY25, staff proposed a shift to a more structured, transparent, and competitive process. This will be conducted through a **Notice of Funding Opportunity (NOFO)**, which opens the application window ending on August 1, 2025. The NOFO will specify eligible project types and funding priorities, which include:

- · Technology projects
- Planning projects
- · Small regional capital projects

BOND LIST-FIRST READ

Abby Marinelli delivered a presentation on staff's recommendation for the annual Bond List submittal to the Governor's Office and the General Assembly. State law requires the ATL to annually submit a list of projects of state and regional significance for potential inclusion in state general obligation bond funding. Staff recommended no projects for submission.
